# Service Fees

## As of 01/08/2024

We aim to make our service accessible to our community and try to ensure that cost is not a barrier. Our FSA Health and Wellbeing stream does not receive any external or sustainable funding. As we continue to see an overwhelming demand for our services, our fees are necessary to continue to operate and are increasing to reflect the cost of continued resourcing of this service stream. Should you need to access support, but are in significant financial distress, please let us know and we can discuss this with you. Please note that all sessions below refer to a 50-minute session unless otherwise specified.

All fees for psychology sessions are set well below the Australian Psychological Society's (APS) recommended fee schedule of **\$300.00 per session**.

The cost of providing Medicare services is further subsidized by Family Services Australia, to make our service more accessible to our clients.

All rates for NDIS funded services are based on current NDIS Price Guides. NDIS support typically requires a greater amount of preparation, case conferencing and case management for our clinical staff, making it necessary for us to charge in line with NDIS recommendations.
